SAPPHIRES & SEQUINS SHINES LIGHT ON MENTAL HEALTH

It was big and lively with drinks, music, a raffle, a fashion show, and more. It looked like an impressive girls' night out...but it was so much more.

In May 2022, more than 200 women attended Sapphires & Sequins at Hamilton Farm Golf Club. The glamorous event, organized by the Hunterdon Health Auxiliary, was no ordinary social gathering. Raising more than \$117,000 for the Hunterdon Health Foundation, it was a party with a purpose, as are all the Auxiliary's activities.

Formed alongside the opening of the hospital in 1953, the Auxiliary continues to play a vital role in supporting health and wellness in the county. This group of dedicated volunteers has been organizing charitable and educational activities to support programs at Hunterdon Health for decades.

"This is a group of generous women who are passionate about people and have hearts for helping others," remarked Auxiliary Chair Lynn Coates. "They care deeply about the community."

Their thoughtful care for community was on display in their choice to support renovations to the Louis Leicester Center last year. The Center, which is the home for behavioral healthcare for those with mental illness, emotional difficulties, or addiction, received a major facelift

in 2022—from renovated bathrooms to fresh paint to coordinating furniture and more. For the Auxiliary, the update was an important investment in the care and treatment of every adolescent and adult that visits the Center.

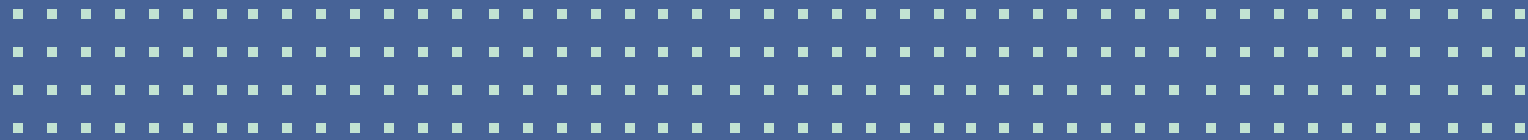
"COVID brought the importance of mental healthcare out of the shadows, and we want to continue to shine a light on the issue. We wanted to demonstrate to those who are bravely struggling that we recognize their value by giving them an atmosphere for care that upholds their dignity and communicates that they are a priority." Beyond their support of the Louis Leicester Center last year, the Auxiliary also gave \$50,000 to the Hunterdon County Medication Access Program, to help local individuals who are unable to afford necessary prescription medications.

This year marks 70 years of the Auxiliary's compassion in action—generations of women, coming together, giving their time, talents, and treasure to improve health in our community. From traditional bake sales to lunch and learn opportunities to the signature Sapphires & Sequins gathering and the annual Lights of Love event, they have activities planned throughout the year to celebrate and continue their mission of support. EMERGENCY DEPARTMENT EXPANSION DELIVERS MORE ADVANCED, PRIVATE CARE

Emergency care at Hunterdon Health looks a little different these days. It's still the lifesaving care you can count on. But now, it's more. More private. More personal. More efficient. And that means, it's better for you and for everyone.

After months of construction, Hunterdon Health Emergency Department opened its doors to eight new private rooms this month. The expansion came in response to the growing needs of our evolving community and is part of Hunterdon's overarching commitment to innovation and compassionate care.



As emergency departments across the nation are experiencing overcrowding, which too often leads to long wait times and a chaotic atmosphere, Hunterdon expanded to ensure the most healing environment for every patient.

The addition brings the department total to 30 private rooms. But the new rooms offer much more than just added space. They incorporate

intentional and innovative design elements that will provide the safest, most comfortable experience for patients with any needs, including the area's growing population of behavioral health patients.

Like communities throughout the country, Hunterdon is seeing a rising need for behavioral healthcare. This can lead to the potential for overcrowding and disruption in the emergency services environment. The ED expansion will help alleviate those issues, resulting in superior care that protects the dignity of every patient.

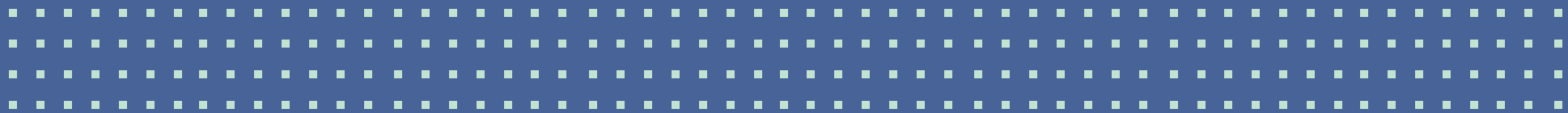
While the new rooms stand ready to care for patients with any emergency need, they boast leading-edge design and safety-related technologies that allow them to be transformed in an instant to address the unique emergency care needs of those struggling with mental health or substance abuse issues. The end result is exceptional, personal, private, and complete care for each individual.

"Our pledge to our patients has always been to provide the best care at the right time in the most appropriate setting. This expansion is directly tied to that promise," reports Kristy Alfano, Chief Operating Officer of Hunterdon Health. "We now have the ability to provide everyone in the community a safer, quieter, more private emergency care experience."

The ED expansion is good medicine and compassionate care at its finest. With a leading gift from ShopRite of Hunterdon County, operated by the Colalillo Family, the expansion was 100% funded by private gifts from local residents and corporations and support from the State of New Jersey. BREAKING DOWN BARRIERS:

COMMUNITY PARTNERSHIPS CLEAR PATHS TO BETTER HEALTH

A 911 dispatcher hears a catch in the elderly man's voice as he talks. Miles from the hospital with no car, no family, and no way to get to his radiation appointment, he's afraid of what will happen to him if he misses another treatment. He whispers, "I don't know what to do."

That scenario is a heartbreaking reality for some of our neighbors. Those experiencing economic hardship are struggling with lack of transportation, poor nutrition, and limited access to proper care. And the impact on their health can be devastating.

Hunterdon Health Foundation recognizes those challenges and actively collaborates with other local organizations to address critical needs in the county. As a key member of the Hunterdon County Partnership for Health, the Foundation funds a variety of community health services designed to eliminate barriers to transportation, proper nutrition, and care, ultimately helping individuals and families take better control of their health.

Last year, with the generous support of compassionate donors, including major foundation and corporate donors like **Provident Bank Foundation, Northfield Bank Foundation, TD Charitable Foundation, J&J Somerset County Companies Contribution Fund,** and **Novo Nordisk**, hundreds of friends and neighbors received critical assistance...and lived healthier lives.

Hunterdon's Transportation Access Program helped to identify older adults and those with special mobility needs who were at risk of missing medical appointments. Through partnerships with local transportation organizations goHunterdon and Hunterdon County Paratransit Service, patients received reminder phone calls, safe



rides to their appointments, and even follow up calls after they arrived home. Hunterdon also invited patients living with chronic health conditions, like diabetes, into our Produce Prescription Program. Family and specialty practices offered prescriptions for healthy foods, which provided families with fresh produce every week through partnerships with local food pantries and America's Grow-a-Row, a local nonprofit that grows and distributes produce to those in need. As a result, patients began to feel better and their doctors reported reduced weight, lower AC1 levels, and overall improvements in their health.

Healthcare at Hunterdon is about more than medicine. It's about people and that is reflected in the many community outreach programs and partnerships supported by the Foundation.

"This is a family community," explained Kim Blanda, Director of Community Relations, "and at the end of the day, our goal is to help people. But we aren't doing it alone. We are doing it with our community partners...and, importantly, with our donors."

At the heart of all the Foundation does is the generosity of our donors. Hunterdon's care for people starts with the kindness of the people who give to the Foundation. Whether large contributions from major corporate and foundation donors or modest gifts from individuals, every donation is an investment in life and health. And for neighbors like the gentleman whose future depended on a ride, each one is priceless.

HOW THE LIFE OF ONE NURSE AND VOLUNTEER CONTINUES TO IMPACT LOCAL CARE

When Tom Watkinson speaks of his mom, you can't help but wish you had known Gladys. Kind. Caring. Generous. Even today, years after her passing, her compassion continues to shape lives, through the generous scholarship fund established in her honor.

Gladys was many things in life: wife, nurse, mother, and dedicated volunteer to name a few. As a young woman, she married a Navy pilot and practiced as a registered nurse. In 1960, the couple moved to a farm in Hunterdon County where she devoted herself to raising their three boys.

As her children grew, her caring nature and love of community drew her back to the hospital. Gladys began showing up regularly as a volunteer at Hunterdon Medical Center. For 40 years, she could be found in just about any department, helping however and wherever she was needed.

Before her passing in 2011, she and her husband established the Wingover Scholarship for Nursing Education through the Hunterdon Health Foundation as a way for Gladys to continue sharing her passion for nursing. Originally named after the family farm, the scholarship fund has been providing scholarships for nursing students for over a decade, helping train the next generation of caregivers in Hunterdon County.

In 2022, after their father passed, the Watkinson sons, Tom, Ted, and Drew, made a gift to the Hunterdon Health Foundation

that would double the size of the scholarship fund. It was their father's wish. And in remembrance of their mother whose influence continues to guide her sons and enrich her community, they renamed the scholarship to bear her name: the Gladys Benfield Watkinson Scholarship for Nursing Education.

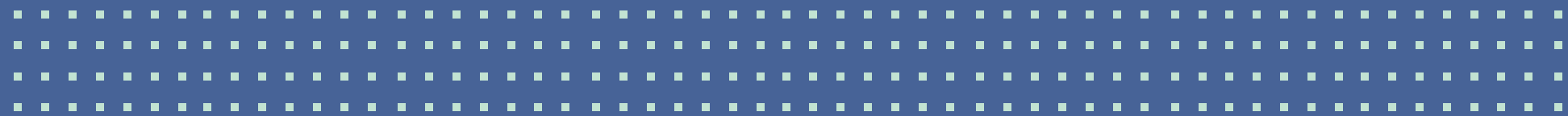
"My mom was a wonderful, caring, and generous person. She wanted to do everything she could to help at the hospital and anything to encourage people to get into the nursing profession," Tom commented. "My brothers and I are proud of this fund, and we think she would be very happy with it." With the Watkinson's generous contribution, the fund will provide scholarships to as many as 10 recipients every year, beginning in 2023. And the brothers are all excited to see where it will grow from here, as they work to carry on his mother's legacy of generosity and care.

Twelve years after her passing, Gladys is still caring for this community every day. Her legacy lives on...not only in the generosity of her family, but in the care provided by so many nurses in Hunterdon County whose education she helped provide.

The Gladys Benfield Watkinson Scholarship for Nursing Education is one of several Hunterdon Health Foundation scholarships available to help provide educational opportunities to individuals pursuing careers in healthcare. Scholarships are built on the generosity of caring individuals and families like the Watkinsons.



CONNECTING THE PIECES:



PARTNERING FOR WELLNESS, HONORING LIFE

“What is missing?” It was a question Maggie Baumann couldn’t ignore.

A pandemic-shaken world had chased the issue of mental health from the shadows. And suddenly, Maggie found herself staring down the devastating reality of those struggles in the lives of people all around her...people she cared deeply about.

“It occurred to me that there is almost an epidemic of mental illness. It forced me to ask: ‘What is missing in the world of mental health?’”

But she did more than just ask the question. Maggie and her husband Peter threw their support behind an answer and became lead donors to Hunterdon Health’s new Mental Wellness Partnership Program.

This new program is designed to address mental health care in a comprehensive, holistic way. To approach care for every patient asking,

how do we treat the whole person, not just the diagnoses? Recognizing the powerful impact that exercise and diet have on mental wellness, Hunterdon care partners will incorporate physical fitness, nutrition, and nature into care for adolescent and adult behavioral health patients.

The Baumanns are excited about the potential of a program that intentionally combines care for both physical and mental well-being. Maggie believes it is a key piece of what has been missing all along in traditional mental health care and treatment.

An accomplished business owner, volunteer, wife, mother, and so much more, Maggie contributes much of her own health and success to her active lifestyle. As a young woman, she found her natural energy tending to pull her into a state of stress. To cope, she began running. And she quickly learned how effectively exercise and proper nutrition helped tame and focus her anxious thoughts.



That was the birth of a balanced lifestyle that would propel Maggie through the next five decades. And the dawn of a passion that has drawn her into this venture with Hunterdon Health. But there is more behind her commitment to this effort than her own positive experiences.

For both Maggie and Peter, supporting this program is a labor of love rising out of personal tragedy. It's their way of remembering the beautiful life of a beloved niece, Betsy Boettcher, whom they lost less than a year ago.

"We see this as a chance to be a part of something that might set people on a path to mental wellness, that might help save even one life—and that is how we want to honor our niece's memory," Maggie commented.

The Baumann's generous support of the Mental Wellness Program Partnership is establishing a legacy of compassion and care that they

hope will not only support patients' mental wellness, but also provide an avenue of healing for people, like them, who have experienced such personal loss.

"In establishing this program fund, we hope to create a way for others like us to honor loved ones who they have lost or who continue to struggle with mental health concerns. A way to for people to bring some good from tragedy."

The Mental Wellness Partnership Program, scheduled to launch this year, is a collaboration between Hunterdon Behavioral Health, Hunterdon Health and Wellness Centers, and the Center for Nutrition and Diabetes Management. Designed to help behavioral health patients achieve balanced lifestyles that support overall wellness, it will offer treatment options that blend traditional mental health care with exercise and nutrition guidance, under the supervision of trained professionals. Funded by philanthropy, it will offer people like the Baumanns the opportunity to support this program by making personal gifts, in honor of their loved ones.
